

**NOTICE TO ALL USERS OF THESE PREMISES AND FACILITIES  
– EXCLUSION OF LIABILITY –  
ASSUMPTION OF RISK**

**PLEASE READ CAREFULLY!**

THESE CONDITIONS WILL AFFECT YOUR LEGAL RIGHTS INCLUDING THE RIGHT TO SUE FOR NEGLIGENCE OR BREACH OF CONTRACT OR TO CLAIM COMPENSATION FOLLOWING AN ACCIDENT OR EXPOSURE TO A CONTAGIOUS BACTERIAL OR VIRAL DISEASE SUCH AS COVID-19.

As a condition of participating in events and activities at the Robson Square Ice Rink (the "Activities"), which include but are not limited to ice skating, figure skating, hockey, and other ice-based activities, the ticketholder, including any minor participants for whom the ticketholder is responsible, ASSUMES ALL RISKS associated with participation in the Activities. These risks include, but are not limited to, personal injury (such as cuts, bruises, fractures, and concussions), death, property loss, or exposure to contagious diseases like COVID-19. Risks may arise from factors including, but not limited to, falls, collisions with other participants or objects, equipment failure, and varying ice conditions. By participating, you agree to a FULL RELEASE AND WAIVER OF LIABILITY AND ALL CLAIMS against any person(s), entities or organization(s) associated in any way with the Activities including the rink owners and lessees, promoters, sanctioning bodies, skating associations, or any subdivision thereof, rink operators, sponsors, advertisers, PACE Group Communications Inc., His Majesty The King in Right of the Province of British Columbia and other participants, rescue personnel, event inspectors, underwriters, consultants and others who give recommendations, directions or instructions or engage in risk evaluation and loss control activities, regarding the Activities or the event premises, or any one or more of them and their respective directors, officers, employees, guides, contractors, agents, volunteers and representatives (collectively "the Releasees"). This release and waiver of liability extends to claims on behalf of minor participants to the fullest extent permitted by law. By purchasing a ticket or participating in the Activities, the ticketholder acknowledges that they have read, understood, and agree to abide by all safety guidelines and conduct rules associated with the Activities.

The participant agrees to forego any claim for liability for any loss, damage, injury or expense the participant may suffer as a result of their use of or presence at the event facilities or participation in any part of, or presence in any capacity at, the Activities, due to any cause whatsoever, INCLUDING NEGLIGENCE, GROSS NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE OCCUPIERS LIABILITY ACT ON THE PART OF THE RELEASEES. The agreement between the participant and Releasees is governed by the laws of British Columbia. The participant agrees to comply with all applicable laws and regulations while participating in the Activities.

Any provision in this agreement is declared invalid by a court of competent jurisdiction; such provision will be ineffective only to the extent of such invalidity, illegibility or unenforceability so that the remainder of that provision and all remaining provisions will be valid and enforceable to the fullest extent permitted by applicable law.
